This is to inform all the faculty and staff members of Vishwakarma University Pune that, the Mediclaim & Personal Accident Policy (from United Insurance) are being made available for all the employees of the University. These Schemes are common at BRACT level which are already implemented for VIT & VIIT. The same schemes are made available with a view to provide, at a low cost and on a wholly contributory and self-financing basis, the benefits of an insurance cover to the faculty and staff. Vishwakarma University, Pune is always responding to the needs of all the faculty and staff members. The prior cases of help and support are rightly taken care of by the University. These new Insurance Schemes for all the employees are made available from the academic year 2021-22.

The amount of yearly premium paid initially by the Vishwakarma University, Pune will be recovered from the monthly salary. The scheme will be implemented with immediate effect.

Approximate Premium amount:

- 1. Mediclaim Policy Rs. 2,500/- to Rs. 3,000/- per year (Sum Assured Rs. 1,50,000/-).(in 2020-2021.) It is proposed to enhance by Rs.2,00000/- in the academic year 2021-2022.
- 2. Personal Accident Policy—Rs. 200 to Rs. 500 per year (Sum Assured Rs. 2,00,000/-). (in 2020-2021.) It is proposed to enhance by Rs.5,00000/- in the academic year 2021-2022.
